Reduced prices for companies and educational institutions are granted if the following conditions are met:

- Participation of at least 5 persons per level and certification round
- The company or educational institution is charged for all candidates in an exam.

Unemployed persons and students may complete the certification for the price of the educational institution. A certificate of unemployment or a copy of the student ID must be submitted together with the registration.

Any repetition of the written exam is subject to a fee (same price).

### 1.4.2. AGILE CERTIFICATION WITH EXISTING PROJECT MANAGEMENT CERTIFICATE

If someone has a valid IPMA Level D certificate as a *Project Management Associate*, the *Agile Associate* certificate can be acquired within the framework of a shortened exam.

## **2. ADMINISTRATIVE SERVICES**

### **2.1. ADMINISTRATION OF THE CERTIFICATES**

In the case of additional administrative overheads, such as for example interruptions of the certification process or repeated rescheduling of the deadlines, processing fees of up to CHF 200 shall be charged.

### **2.2. APPEALS**

The deposit fee for appeals amounts to CHF 500.00. If the appeal is denied, the deposit fee will be borne by the appellant. The deposit will otherwise be refunded.
